We are committed to achieving Net Zero emissions by 2035.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Emissions reduction targets

FSG has submitted an updated near-term carbon reduction target to 2030 and a new net zero long-term target to 2045 to the Science Based Targets initiative for validation.

Near term target

FSG commits to reduce absolute scope 1 & 2 (market approach) by 80% and scope 3 GHG emissions from Purchased goods and services, Fuel & Energy Related Activities, Upstream transportation and distribution, Waste Generated in Operations, Business travel, Employee commuting, Use of sold products and End-of-life treatment of sold products by 80% by 2030 from a 2022 base year.

Long term target

FSG commits to reduce absolute scope 1 & 2 (market approach) by 90% and scope 3 GHG emissions from Purchased goods and services, Capital goods, Fuel & Energy Related Activities, Upstream transportation and distribution, Waste Generated in Operations, Business travel, Employee commuting, Use of sold products and End-of-life treatment of sold products and investments by 90% by 2035 from a 2022 base year.

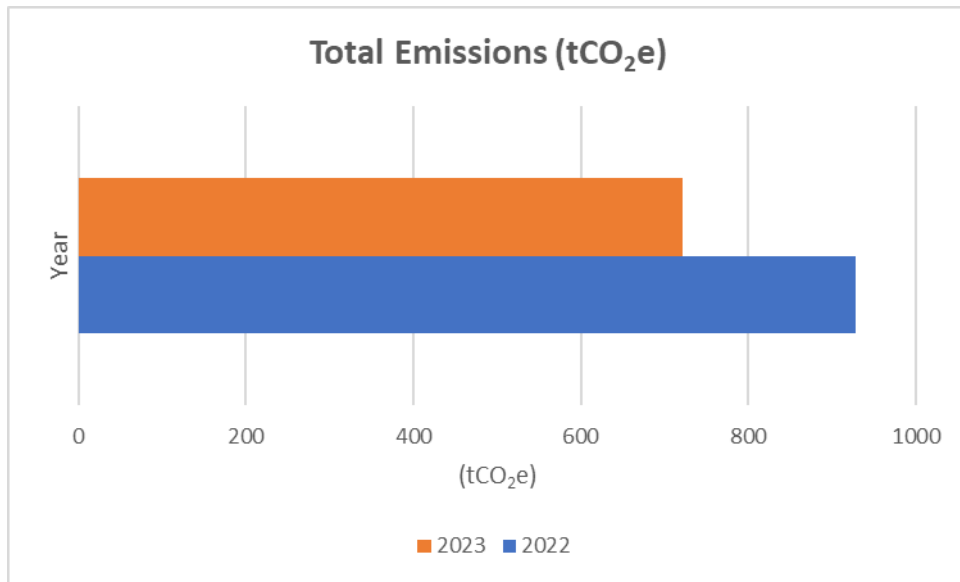

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 206 tCO₂e, a 22%ge reduction against the 2022 baseline and the measures will be in effect when performing the contract.

FSG have reduced emissions from scope 1&2 by 19% by end of 2022 compared to our baseline year of 2020. This has been achieved by increasing the amount of renewable electricity we buy and generate on site from 46% to 73% of the total electricity we source and through our energy efficiency programme which has seen the amount of energy we use reduce by 11% at the end of 2022 compared to our baseline year of 2022


